# PRESIDENT'S REPORT

The past year has been defined by the global COVID-19 pandemic. For the VUL, no ultimate was played between March - June 2020. Modified practices and skills training resumed in June 2020, and modified leagues began playing in September 2020. On December 4, 2020, all adult sport in BC was again suspended under a public health order. We saw a 59% reduction in the number of members playing ultimate this year, and a 71% reduction in league revenue between 2019 and 2020. Given the reduction in revenue and ultimate, our staff voluntarily reduced their hours.

The VUL Staff and Board have worked hard this year on initiatives which included in particular:

- A major focus in 2020 was adapting programming to the realities and changing nature of COVID-19. This included responding to covid-19 public health regulations, viaSport Return to Play, and working with our Provincial Sports Organization partner, BC Ultimate.
- The VUL has selected a firm for the finance function and financial information systems project approved at the last annual general meeting (on January 29, 2020 to use *up to \$30,000 from the VULS capital fund over a 24 month period to upgrade VUL financial systems and processes*).

While we cannot predict when the covid-19 pandemic will end, we certainly expect to be playing ultimate in Vancouver when it does. We can promote resilience by safeguarding the VUL community we have built together. We want the VUL to be in a strong position to return to offering the rich selection of ultimate available in Vancouver and continuing our support of regional development.

The financial impact of the pandemic on the VUL's cash flows has been significant. The VUL has received nearly \$80k in wage subsidies, a \$40k loan, and grants. Adult sports have been suspended and the <u>Joint statement on B.C.'s COVID-19 response on Nov 19, 2020</u> including wording that "*League organizers should continue planning for 2021 with today's modifications in mind.*" Anticipating continued limitations on our ability to play ultimate in 2021 and revenue impacts, the board has approved a motion and recommends that members approve the use of a portion of capital funds toward the VUL's resiliency during COVID-19. The VUL is also accepting donations — thank you to members who have already donated almost \$9000.

### Strategic Plan

The VUL is entering the final year of our 2017-2021 Strategic Plan. This plan has focused on 4 Pillars (Youth, Adult, Regional Support, Leadership) and 6 Foundations (Spirit, Facilities, Communication, Collaboration, Human Resources, Governance). A visual strategic plan report for 2020 was created by the Strategic Plan Committee Chair, Christa Hoy and I suggest reviewing it for details.

Along with continued crisis management, a major task for the 2021 Board of Directors will be to create the next iteration of the strategic plan.
