## 5. VUL Annual Report

- a) The report was delivered by Sarah Cawston-Stewart, Board President and Diane St-Denis, Executive Director (posted on website at <u>Meeting Reports | Vancouver Ultimate League</u> (vul.ca).
  - Programs and membership are returning to pre-pandemic levels.
  - Regional Growth changes in Vancouver field sport strategy may decrease availability
    of fields in Vancouver and require expansion to regional areas. Acknowledgement of
    volunteers Craig Woods and Wendy LeBreton for their contributions in this area
    through the Vancouver Field Sport Federation.
  - Programs launched a new youth club in North Vancouver, saw growth in youth club programs since the pandemic, and had the biggest youth program footprint in the history of the VUL (Vancouver, Richmond, Surrey, and North Vancouver)
  - VUL and BCU will co-host the Canadian Ultimate Championships in Surrey August 13-20, 2023.

- b) Treasurer's Report and Financial Statements were delivered by David Midgley, Treasurer (posted on website at Meeting Reports | Vancouver Ultimate League (vul.ca))
  - Q: Is there any consideration of getting an audit done rather than the compilation?
  - A: The Treasurer has had conversations with the Executive Director and accountant on this topic. The cost of an audit is a barrier. A review may be the first step. This will be an item of discussion with the Finance Committee.
