Q: What was spent from the approved \$30k for the financial project so far.

A: A nominal amount in previous years, but most spending has been near the end of fiscal year (RFP) and implementation costs are ongoing now. We are looking at coming in under budget and do not plan to ask for any additional capital funds for that project.

Q: Has there been any discussion of using some of the approved capital fund outlay to pay CEBA loan?

A: No, there has been no plan or expectation of transitioning this money to that expense. Repayment of the CEBA loan was not the purpose for which the operational backfill funds were approved.
